RESOLUTION AUTHORIZING A CONTRACT FOR SANITARY SEWER CCTV/SONAR INSPECTION - SEWER DISTRICT NO. 1

WHEREAS, The 2018 Rensselaer County Adopted Budget for Sewer District No. 1 (District) provides an appropriation for the purposes of a competitively bid sanitary sewer CCTV/sonar inspection contract; and

WHEREAS, The District's asset management plan includes evaluation and inspection of all District owned sanitary sewers; and

WHEREAS, The District, in conjunction with the County Bureau of Central Services developed a bid specification identifying all gravity sanitary sewer within the District; and

WHEREAS, Request for Bid packages were sent out to companies with expertise in sanitary sewer CCTV/sonar inspection; and

WHEREAS, The lowest responsible bid was received on October 19, 2018 from RedZone Robotics Inc.; and

WHEREAS, The start and end dates of such contract, the source of funding of the same, the total amount to be expended over the life of the same, which shall not exceed budgeted appropriations, and the name and address of the contracting party are as follows:


