**RESOLUTION AUTHORIZING THE PURCHASE AND INSTALLATION OF FIVE (5) SECURITY GATE SLIDING DOOR MOTOR ASSEMBLIES IN THE RENSSELAER COUNTY JAIL AND AMENDING THE 2018 RENSSELAER COUNTY ADOPTED BUDGET- OFFICE OF THE SHERIFF**

WHEREAS, This resolution is filed by the Rensselaer County Executive with the Rensselaer County Legislature; and

WHEREAS, The existing original (1992) sliders located in the Rensselaer County Jail are opened and closed hundreds of times per day and are necessary to maintain proper security of the Correctional Facility; and

WHEREAS, The present sliders are in need of redesign, repair and fortification; mechanical parts needed for repair are no longer manufactured; the cost to maintain existing sliders has exceeded the cost of replacement; often, in-house fabrication is used as a last resort to maintain functionality; and

WHEREAS, The Rensselaer County Office of the Sheriff has solicited (RFB-18-39) and received bids for the purpose of purchasing five security gate sliding door motor assemblies; and

WHEREAS, Maximum Security Products Corporation, 3 Schoolhouse Lane, Waterford, New York 12188 provided the lowest submitted bid which met the specifications as set forth in the Rensselaer County Sheriff's Office Request for Bid at a cost of \$65,175.00; and

WHEREAS, The above purchase is being made in accordance with the policies and procedures set forth in the Rensselaer County Purchasing Guidelines; now, therefore, be it

RESOLVED, That the Rensselaer County Executive or his designee shall be, and hereby is, authorized and empowered to execute the above described purchase; and, be it further

RESOLVED, That the 2018 Rensselaer County Adopted Budget shall be and hereby is amended as follows:


