## RESOLUTION AUTHORIZING AN AGREEMENT FOR JANITORIAL SERVICES - DEPARTMENTS OF SOCIAL SERVICES, PROBATION & YOUTH

**WHEREAS**, This Resolution is filed by the Rensselaer County Executive with the Rensselaer County Legislature; and

**WHEREAS**, The Departments of Social Services, Probation and Youth occupy office space at Flanigan Square, 547 River Street, Troy; and

**WHEREAS**, The current janitorial services contract expires on December 31, 2018; and

**WHEREAS**, The Bureau of Central Services conducted a formal bid, RFB-18-35, Cleaning/Janitorial Services for the Departments of Social Services, Probation and Youth; and

**WHEREAS**, The Bureau of Central Services received six responses, and Temco Service Industries, Inc. dba ATALIAN Global Services submitted the lowest bid, with a total bid amount of \$311,621.00; and

**WHEREAS**, Based on ATALIAN's submission, the annual rates for are as follows: year one \$60,144.00; year two \$60,144.00; year three \$63,144.00; year four \$63,144.00; and year five \$65,045.00; and

**WHEREAS**, The start and end dates of such contract, the source of funding for same, the name and address of the contracting parties, and the total amount to be expended over the life of same, which shall not exceed budgetary appropriations, are as follows:
