**RESOLUTION AUTHORIZING A CONSTRUCTION CONTRACT FOR REPLACEMENT OF RAMPS
AND STAIRS AT THE COUNTY OFFICE BUILDING AND AMENDING THE 2018
ADOPTED RENSSELAER COUNTY BUDGET - ENGINEERING DEPARTMENT**

WHEREAS, This resolution is filed with the County Legislature by the Rensselaer County Executive; and

WHEREAS, The Ned Pattison County Government Center (also known as the County Office Building), located at 1600 Seventh Avenue, Troy, New York, is in need of repairs to the third floor exterior ramps and the north exterior stairs; and

WHEREAS, A contractor with the knowledge, expertise and necessary certifications to perform the work is required; and

WHEREAS, Plans and specifications for the work were prepared by Clark Patterson Lee architects and bids for the project were received on April 26, 2018; and

WHEREAS, The selection of the contractor to execute the construction of the project in accordance with the plans and specifications is based on capability and the lowest cost to the County; and

WHEREAS, The source of funding of the desired contract, the total amount to be expended over the life of the contract, and the name and address of the contracting party are as follows:
