RESOLUTION AUTHORIZING THE EXECUTION OF CONTRACT FOR BITUMINOUS ASPHALT PAVING, HEATING AND SCARIFYING - HIGHWAY DEPARTMENT

WHEREAS, This resolution is filed with the County Legislature by the Rensselaer County Executive; and

WHEREAS, Bids for bituminous asphalt paving, heating and scarifying have been solicited and are acceptable based upon the specifications; and

WHEREAS, The desired agreement would be in effect through August 31, 2019, with a one year extension clause if mutually agreeable, provided the vendor continues to meet specifications; and

WHEREAS, Selection of the contractor is based upon lowest cost to the County; and

WHEREAS, The name and address of the contracting party, the start and end dates of the proposed agreement, with the designated sources of funding being limited to appropriation codes D.5110.04500, D.5112.04500 and D.5112.04800, and the total amount to be expended over the life of the agreement, which shall not exceed budgeted appropriations, are as follows:


