RESOLUTION AUTHORIZING CONTRACTS FOR THE PURCHASE OF HOT MIX ASPHALT PRODUCTS AND TRUCKING — HIGHWAY DEPARTMENT

WHEREAS, This resolution is filed with the Rensselaer County Legislature by the Rensselaer County Executive; and

WHEREAS, Bids for the purchase of hot mix asphalt products and trucking have been solicited and are acceptable based upon the specifications, and the desired agreements are for one year with a one year extension clause, if mutually agreeable, provided all vendors continue to meet specifications; and

WHEREAS, Selection of the vendor, location, delivery, etc. will be based upon lowest cost and availability to the County; and

WHEREAS, The names and addresses of the contracting parties, the start and end dates of the noted agreements, the designated sources of funding being limited to budget appropriation codes: D.5110.04500, D.5112.04500 and D.5120.04500, and the total amount to be expended over the life of the agreements, which shall not exceed budgeted appropriations, are as follows:

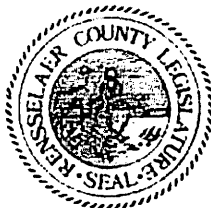
