**RESOLUTION AUTHORIZING THE PURCHASE AND INSTALLATION OF TWO (2) DISHWASHER UNITS FOR THE RENSSELAER COUNTY CORRECTIONAL FACILITY AND AMENDING THE 2018 RENSSELAER COUNTY ADOPTED BUDGET- OFFICE OF THE SHERIFF**

WHEREAS, This resolution is filed by the Rensselaer County Executive with the Rensselaer County Legislature; and

WHEREAS, The existing dishwasher, installed in 2010 as part of the expansion project, has reached its expected end of life cycle of 8-10 years, no longer operates to capacity and needs to be replaced before it fails; and

WHEREAS, Additionally, a smaller back-up dishwasher will be installed adjacent to the main dishwasher to be used in the event of needed maintenance or malfunction; and

WHEREAS, The Rensselaer County Sheriff's Office has solicited (RFB-18-40) and received bids for the purpose of purchasing two dishwashers; and

WHEREAS, B&G Foodservice Equipment & Supplies, 60 Commerce Avenue, Albany, New York 12206 provided the lowest submitted bid which met the specifications as set forth in the Rensselaer County Sheriff's Office Request for Bid at a cost of \$71,180.00; and

WHEREAS, The above purchase is being made in accordance with the policies and procedures set forth in the Rensselaer County Purchasing Guidelines; now, therefore, be it

RESOLVED, That the Rensselaer County Executive or his designee shall be, and hereby is, authorized and empowered to purchase the aforementioned equipment at a cost not to exceed \$71,180.00 from appropriation code A.3152.02400 (Other Equipment); and, be it further

RESOLVED, That the 2018 Rensselaer County Adopted Budget shall be and hereby is amended as follows:
