RESOLUTION AUTHORIZING THE PURCHASE OF COLD MILLING - HIGHWAY DEPARTMENT

WHEREAS, This Resolution is filed with the County Legislature by the Rensselaer County Executive; and

WHEREAS, Bids for the purchase of cold milling have been solicited and are acceptable based upon the specifications; and

WHEREAS, The desired agreements would be in effect through December 31, 2019, with a one year extension clause if mutually agreeable, provided the vendor continues to meet specifications; and

WHEREAS, Selection of the vendor will be based upon lowest cost and availability to the County; and

WHEREAS, The names and addresses of the contracting parties, the start and end dates of the desired agreements, the designated sources of funding being limited to the budget appropriation codes noted below, and the total amount to be expended over the life of the agreements, which shall not exceed budgeted appropriations, are as follows:
