Skill practices and on-the-spot defensive driving techniques help change bravado to confidence.

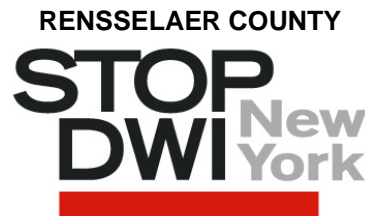

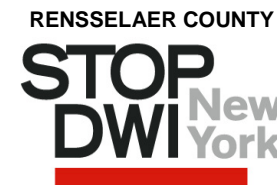

**The panel will be held in the Bulmer Telecommunications Center's Auditorium at the Hudson Valley Community College Campus in Troy, not at the court where you were sentenced.**

The program will begin at 5:00 pm **SHARP** and you must be signed in and seated before the class begins, failure to comply with this requirement will bar you from attendance. **It is recommended that you arrive just prior to 4:30p.m. and expect to be released at approximately 9:00 p.m.**

**Preregistration is SUGGESTED**, for those individuals who miss the deadline, they will be permitted to register at our office or come directly to class and register that evening. We accept personal checks, money orders, and certified bank checks, via mail payable to Rensselaer County STOP-DWI. You may pay cash at our office or the night of the panel.
